

## **2023 TEAM SELECTION CRITERIA**

## **Premier IPT**

## **Information**

- The Premier Inter Provincial Tournament annually takes place in September, and the 12 (twelve) man Squad will be announced in April of each year.
- The Squad members will then be evaluated, play Open tournaments, Match Play against each other, and the final 8 (eight) man Team with 4 (four) reserves will be announced after the Southern Cape Closed Championship in June of each year.

#### **Age Limit**

- No age limit applies.
- The SCGU however retains the right not to select a golfer who is still of school going age to represent the Union at this level.

## **Minimum Requirements**

- A player must play in 8 tournaments (eight) in SCGU Order of Merit events.
- A player must play in 50% of the Super League matches for his respective Club or Team.
- The SCGU may at its discretion disregard the requirement to play in 50% of the league matches should extenuating circumstances exist.

#### **GolfRSA Conditions**

Players that have moved to the Southern Cape, must be an affiliated member of a golf club
and handicapped in the Southern Cape region for at least 6 (six) months, before being
eligible for SCGU Team selection. The 6 (six) month window applies from handicap
effective date, until start of respective IPT/Team event. Exception may be granted by
GolfRSA should a player have permanently relocated to a different Union.

#### **SCGU Conditions**

- PLAYERS AT ANY LEVEL OF SELECTION MAY AT THE DISCRETION OF THE SOUTHERN CAPE EXECUTIVE COMMITTEE, BE OVERLOOKED FOR SELECTION, IRRESPECTIVE OF THEIR POSITION ON THE ORDER OF MERIT SHOULD SUCH PLAYERS HAVE A POOR TEAM PERFORMANCE RECORD & CONTRIBUTION TO TEAM MORALE, OR DISCIPLINARY RECORD AT EITHER TEAM, CLUB OR PROVINCIAL LEVEL.
- SHOULD A PERSON QUALIFY ON MORE THAN ONE ORDER OF MERIT SCGU RESERVES THE RIGHT TO ADD AN ADDITIONAL WILD CARD.

## <u>Automatic Selection (Squad) – In Order of Qualification</u>

- The top 2 (two) players on the GolfRSA Amateur Golf Ranking (Top 50).
- The top 2 (two) players on the SCGU Accumulated Points Order of Merit.
- The top 2 (two) players on the SCGU Dynamic Ranking Order of Merit.
- The top 2 (two) players on the SCGU Stroke Average Order of Merit.

## Wild Card or Selectors Picks (Squad)

• The selectors may, at their discretion, select any 4 (four) players who are members of a Golf Club affiliated to the SCGU. The selection of such players is not restricted to any minimum requirements or position on the Order of Merit.

## **Final Team Selection**

• The selectors may, at their discretion, select any 8 (eight) players from the 12 (twelve) man Squad. Selection will be based on player evaluation and the grounds of previous experience (whether perceived or real), Match Play and Foursomes' records or how players fit into the team dynamic.

## **Mid-Amateur IPT**

#### Information

• The Mid-Amateur Inter Provincial Tournament annually takes place in October, and the side will be announced after the Southern Cape Closed Championship in June of each year.

#### **Age Limit**

Players must be 30 (thirty) years of age at the start of the Mid-Amateur IPT.

## **Minimum Requirements**

- A player must play in 8 tournaments (eight) in SCGU Order of Merit events.
- A player must play in 50% of the Super League matches for his respective Club or Team.
- The SCGU may at its discretion disregard the requirement to play in 50% of the league matches should extenuating circumstances exist.

### **GolfRSA Conditions**

- Any player that represented the Union in the Premier IPT side will not be allowed to represent the Union in the Mid-Amateur IPT of that same year.
- Players that have moved to the Southern Cape, must be an affiliated member of a golf club
  and handicapped in the Southern Cape region for at least 6 (six) months, before being
  eligible for SCGU Team selection. The 6 (six) month window applies from handicap
  effective date, until start of respective IPT/Team event. Exception may be granted by
  GolfRSA should a player have permanently relocated to a different Union.

### **SCGU Conditions**

- PLAYERS AT ANY LEVEL OF SELECTION MAY AT THE DISCRETION OF THE SOUTHERN CAPE EXECUTIVE COMMITTEE, BE OVERLOOKED FOR SELECTION, IRRESPECTIVE OF THEIR POSITION ON THE ORDER OF MERIT SHOULD SUCH PLAYERS HAVE A POOR TEAM PERFORMANCE RECORD & CONTRIBUTION TO TEAM MORALE, OR DISCIPLINARY RECORD AT EITHER TEAM, CLUB OR PROVINCIAL LEVEL.
- SHOULD A PERSON QUALIFY ON MORE THAN ONE ORDER OF MERIT SCGU RESERVES THE RIGHT TO ADD AN ADDITIONAL WILD CARD.

### **Automatic Selection – In Order of Qualification**

- The top player on the SCGU Mid-Amateur Accumulated Points Order of Merit.
- The top 2 (two) players on the SCGU Mid-Amateur Dynamic Ranking Order of Merit.
- The top 2 (two) player on the SCGU Mid-Amateur Stroke Average Order of Merit.

#### **Wild Card or Selectors Picks**

- The selectors may, at their discretion, select any 3 (three) players who are members of a Golf Club affiliated to the SCGU. The selection of such players is not restricted to any minimum requirements or position on the Order of Merit.
- In the event of the Mid-Amateur IPT Team, the selector's picks may be made on the grounds of previous experience (whether perceived or real), match play records or how players fit into the team dynamic.

# **Country Districts**

#### Information

• The Country Districts Provincial Tournament annually takes place in May, and the side will be announced in March of each year.

### **Minimum Requirements**

- A player must play in 6 tournaments (six) in SCGU Order of Merit events.
- A player must play in 50% of the Super League matches for his respective Club or Team.
- The SCGU may at its discretion disregard the requirement to play in 50% of the league matches should extenuating circumstances exist.

## **GolfRSA Conditions**

- The Southern Cape Golf Union will ensure that all representative teams are selected in accordance with the conditions as set by GolfRSA.
- One of the Country Districts conditions is that no player that represented the Union in the Premier IPT or Mid-Amateur IPT the year before will be allowed to represent the Union in the Country Districts the following year.
- Players that have moved to the Southern Cape, must be an affiliated member of a golf club
  and handicapped in the Southern Cape region for at least 6 (six) months, before being
  eligible for SCGU Team selection. The 6 (six) month window applies from handicap
  effective date, until start of respective IPT/Team event. Exception may be granted by
  GolfRSA should a player have permanently relocated to a different Union.

### **SCGU Conditions**

- PLAYERS AT ANY LEVEL OF SELECTION MAY AT THE DISCRETION OF THE SOUTHERN CAPE EXECUTIVE COMMITTEE, BE OVERLOOKED FOR SELECTION, IRRESPECTIVE OF THEIR POSITION ON THE ORDER OF MERIT SHOULD SUCH PLAYERS HAVE A POOR TEAM PERFORMANCE RECORD & CONTRIBUTION TO TEAM MORALE, OR DISCIPLINARY RECORD AT EITHER TEAM, CLUB OR PROVINCIAL LEVEL.
- SHOULD A PERSON QUALIFY ON MORE THAN ONE ORDER OF MERIT SCGU RESERVES THE RIGHT TO ADD AN ADDITIONAL WILD CARD.

- The top player on the SCGU Country District Accumulated Points Order of Merit.
- The top 2 (two) players on the SCGU Country District Dynamic Ranking Order of Merit.
- The top 2 (two) player on the SCGU Country District Stroke Average Order of Merit.

## **Wild Card or Selectors Picks**

- The selectors may, at their discretion, select any 3 (three) players who are members of a Golf Club affiliated to the SCGU. The selection of such players is not restricted to any minimum requirements or position on the Order of Merit.
- In the event of the Country Districts Team, the selector's picks may be made on the grounds of previous experience (whether perceived or real), match play records or how players fit into the team dynamic.

## **Senior IPT**

#### Information

• The Senior Inter Provincial Tournament annually takes place in April, and the side will be announced after the Southern Cape Senior Closed Championship in January of each year.

### **Age Limit (Minimum)**

Players must be 50 (fifty) years of age on the start date of the Senior IPT.

### **Minimum Requirements**

- A player must play in 8 rounds (eight) in SCGU Senior Order of Merit counting tournaments.
- A player must play in 50% of the Senior Super League matches for his respective Club or Team. SCGU may at its discretion disregard the requirement to play in 50% of the League matches should extenuating circumstances exist.
- Performance of senior players in national order of merit tournaments will strongly be considered for team selection.

## **GolfRSA Conditions**

- One of the Senior IPT conditions is that no player that represented the Union in the Premier IPT or Mid-Amateur IPT the year before will be allowed to represent the Union in the Senior IPT the following year.
- Players that have moved to the Southern Cape, must be an affiliated member of a golf club
  and handicapped in the Southern Cape region for at least 6 (six) months, before being
  eligible for SCGU Team selection. The 6 (six) month window applies from handicap
  effective date, until start of respective IPT/Team event. Exception may be granted by
  GolfRSA should a player have permanently relocated to a different Union.

#### **SCGU Conditions**

- To ensure our best Teams compete at all times, SCGU does reserve the right to choose any player over 60 (sixty) years of age (Super Senior IPT player) for the Senior IPT side.
- PLAYERS AT ANY LEVEL OF SELECTION MAY AT THE DISCRETION OF THE SOUTHERN CAPE EXECUTIVE COMMITTEE, BE OVERLOOKED FOR SELECTION, IRRESPECTIVE OF THEIR POSITION ON THE ORDER OF MERIT SHOULD SUCH PLAYERS HAVE A POOR TEAM PERFORMANCE RECORD & CONTRIBUTION TO TEAM MORALE, OR DISCIPLINARY RECORD AT EITHER TEAM, CLUB OR PROVINCIAL LEVEL.
- SHOULD A PERSON QUALIFY ON MORE THAN ONE ORDER OF MERIT SCGU RESERVES THE RIGHT TO ADD AN ADDITIONAL WILD CARD.

## <u>Automatic Selection – In Order of Qualification</u>

- The top 1 (ONE) player on the SCGU Seniors Accumulated Points Order of Merit.
- The top 2 (two) players on the SCGU Seniors Dynamic Ranking Order of Merit.
- The top player on the SCGU Seniors Stroke Average Order of Merit.

### **Wild Card or Selectors Picks**

- The selectors may, at their discretion, select any 4 (FOUR) players who are members of a Golf Club affiliated to the SCGU. The selection of such players is not restricted to any minimum requirements or position on the Order of Merit.
- In the event of the Senior IPT Team, the selector's picks may be made on the grounds of previous experience (whether perceived or real), match play records or how players fit into the team dynamic.

• The 2022 Team selection will also be taken into account when choosing the team for 2023.

# **Super Senior IPT**

#### Information

 The Super Senior Inter Provincial Tournament annually takes place in April, and the side will be announced after the Southern Cape Senior Closed Championship in January of each year.

## **Age Limit**

• Only players that are 60 (sixty) years of age will be eligible for the Super Senior IPT.

## **Minimum Requirements**

• A player must play in 6 rounds (six) in SCGU Senior Order of Merit tournaments.

### **GolfRSA Conditions**

- One of the Super Senior IPT conditions is that no player that represented the Union in the Premier IPT or Mid-Amateur IPT the year before will be allowed to represent the Union in the Super Senior IPT the following year.
- Players that have moved to the Southern Cape, must be an affiliated member of a golf club
  and handicapped in the Southern Cape region for at least 6 (six) months, before being
  eligible for SCGU Team selection. The 6 (six) month window applies from handicap
  effective date, until start of respective IPT/Team event. Exception may be granted by
  GolfRSA should a player have permanently relocated to a different Union.

### **SCGU Conditions**

- If both Inter Provincials are played over the same period a Super Senior player automatically qualifying for the Senior IPT side, will be selected for the Super Senior IPT side. Super Senior IPT players will not have the option to choose which Team he would like to represent.
- To ensure our best Teams compete at all times, SCGU does reserve the right to choose any Super Senior IPT player for the Senior IPT side.
- If GolfRSA split the Super Senior IPT and the Senior IPT; any such Super Senior IPT players will have the option to play in both the Inter Provincials.
- PLAYERS AT ANY LEVEL OF SELECTION MAY AT THE DISCRETION OF THE SOUTHERN CAPE EXECUTIVE COMMITTEE, BE OVERLOOKED FOR SELECTION, IRRESPECTIVE OF THEIR POSITION ON THE ORDER OF MERIT SHOULD SUCH PLAYERS HAVE A POOR TEAM PERFORMANCE RECORD & CONTRIBUTION TO TEAM MORALE, OR DISCIPLINARY RECORD AT EITHER TEAM, CLUB OR PROVINCIAL LEVEL.
- SHOULD A PERSON QUALIFY ON MORE THAN ONE ORDER OF MERIT SCGU RESERVES THE RIGHT TO ADD AN ADDITIONAL WILD CARD.

- The top Super Senior player on the SCGU Seniors Accumulated Points Order of Merit.
- The top Super Senior player on the SCGU Seniors Dynamic Ranking Order of Merit.
- The top Super Senior player on the SCGU Seniors Stroke Average Order of Merit.

## Wild Card or Selectors Picks - 4 (Four) Man Teams

• The selectors may, at their discretion, select 1 (one) player who is a member of a Golf Club affiliated to the SCGU. The selection of such a player is not restricted to any minimum requirements or position on the Order of Merit.

- In the event of the Super Senior IPT Team, the selector's picks may be made on the grounds of previous experience (whether perceived or real), match play records or how players fit into the team dynamic.
- The 2022 Team selection will also be taken into account when choosing the team for 2023.

# **Senior Triangular Tournament**

#### Information

 The Senior Quintangular Provincial Tournament annually takes place in July, and the side will be announced after the Southern Cape Senior Closed Championship in January of each year.

## **Age Limit**

 Only players that are over 50 (fifty) years of age will be eligible for the Senior Quintangular Tournament.

## **Minimum Requirements**

• A player must play in 8 rounds (eight) in SCGU Senior Order of Merit tournaments.

#### **GolfRSA Conditions**

• Players that have moved to the Southern Cape, must be an affiliated member of a golf club and handicapped in the Southern Cape region for at least 6 (six) months, before being eligible for SCGU Team selection. The 6 (six) month window applies from handicap effective date, until start of respective IPT/Team event.

## **SCGU Conditions**

- No player that represented the Union in the Senior IPT or Super Senior IPT the year before will be allowed to represent the Union in the Senior Triangular Tournament the following year.
- PLAYERS AT ANY LEVEL OF SELECTION MAY AT THE DISCRETION OF THE SOUTHERN CAPE EXECUTIVE COMMITTEE, BE OVERLOOKED FOR SELECTION, IRRESPECTIVE OF THEIR POSITION ON THE ORDER OF MERIT SHOULD SUCH PLAYERS HAVE A POOR TEAM PERFORMANCE RECORD & CONTRIBUTION TO TEAM MORALE, OR DISCIPLINARY RECORD AT EITHER TEAM, CLUB OR PROVINCIAL LEVEL.

## <u>Automatic Selection – 6 Man Teams – 18 Hole Courses</u>

• The top 4 (four) available players on the Southern Cape Senior Quintangular Order of Merit who are not restricted for selection to this side.

## Automatic Selection – 8 Man Teams – 18 Hole Courses

• The top 6 (six) available players on the Southern Cape Senior Quintangular Order of Merit who are not restricted for selection to this side.

## Wild Card or Selectors Picks - 6 or 8 Man Teams - 18 Hole Courses

- The selectors may, at their discretion, select any 2 (two) players who are members of a
  Golf Club affiliated to the SCGU. The selection of such players is not restricted to any
  minimum requirements or position on the Order of Merit.
- In the event of the Senior Triangular IPT Team, the selector's picks may be made on the grounds of previous experience and records (whether perceived or real), or how players fit into the team dynamic.

# **U/19 IPT**

#### Information

• The U/19 Inter Provincial Tournament annually takes place in December, and the side will be announced in October of each year.

#### Age Limit

• Only players that are under 19 (Nineteen) years of age at the start of the tournament will be eligible for the U/19 IPT.

## **Minimum Requirements**

- A player must play a minimum of 30% of all rounds at counting tournaments. The counting tournaments are the SCGU Junior and Mens tournaments as per the SCGU fixture list.
- It is required of a player to play at least 2 (two) tournaments within the 3 months preceding selection to qualify for automatic selection.
- For the 2022-year Dynamic / Performance ranking Order of Merit will be maintained: This Order of Merit requires a minimum of 30% of all rounds to be played at Southern Cape Golf Counting Tournaments for selection purposes, but the player may well appear on the Order of Merit despite not having played the required minimum number of Tournaments and calculates the score of the position of the player in relation to the rest of the field rather than an actual score (this therefore takes out the effects of adverse weather conditions in a tournament).
- The best 80% of differentials for a player will be used.
- The above Order of Merits it will be calculated on the previous 9 months' results on moving basis (exclusive of December).
- A player must play in 50% of the Super League matches for his respective Club or Team.
- The SCGU may at its discretion disregard the requirement to play in 50% of the league matches should extenuating circumstances exist.

#### **GolfRSA Conditions**

- The Southern Cape Golf Union will ensure that all representative teams are selected in accordance with the conditions as set by GolfRSA.
- <u>2016</u>: As from 1 January 2016, 2 (two) players of colour <u>must</u> represent this Team. Should these players not be an automatic selection (top 5), then the wild card or selectors' picks will go to these players to adhere to the GolfRSA conditions.
- Players that have moved to the Southern Cape, must be an affiliated member of a golf club
  and handicapped in the Southern Cape region for at least 6 (six) months, before being
  eligible for SCGU Team selection. The 6 (six) month window applies from handicap
  effective date, until start of respective IPT/Team event. Exception may be granted by
  GolfRSA should a player have permanently relocated to a different Union.

#### **SCGU Conditions**

 PLAYERS AT ANY LEVEL OF SELECTION MAY AT THE DISCRETION OF THE SOUTHERN CAPE EXECUTIVE COMMITTEE, BE OVERLOOKED FOR SELECTION, IRRESPECTIVE OF THEIR POSITION ON THE ORDER OF MERIT SHOULD SUCH PLAYERS HAVE A POOR TEAM PERFORMANCE RECORD & CONTRIBUTION TO TEAM MORALE, OR DISCIPLINARY RECORD AT EITHER TEAM, CLUB OR PROVINCIAL LEVEL.

## **Automatic Selection**

- 1. The Top 2 players from the Top 50 positions on the GolfRSA National Order of Merit will automatically qualify for selection. Should a player be unavailable then only 1 player will be selected under this option or none should both the top 2 players be unavailable for selection. In either instance where a player/(s) is/are unavailable the option of selection under this method of selection will then form part of the "Wild Card" / "Selectors Pick" options.
- 2. The top 2 available eligible players on the Dyanmic / Performance ranking Order of Merit that do not form part of 1 above will qualify for selection.
- 3. The remaining 4 (four) players (or additional players that are not chosen under 1 above) will be chosen as per the "Wild Card" / "Selectors Pick" below. Wild Card or Selectors Picks

# **Women's Premier IPT**

- The Women's Premier Inter Provincial Tournament annually takes place in October, and the 4 (four) ladies will be announced in July of each year.
- Dynamic Order of Merit System will be used for the women's division. It remains the responsibility of the player to inform the Union of any national events that you played and your results in order to count for the SCGU Dynamic Ranking. Selected GolfRSA events will count for team selection.

## Age Limit

- No age limit applies.
- The SCGU however retains the right not to select a golfer who is still of school going age to represent the Union at this level.

### **Minimum Requirements**

• A player must play in 6 tournaments (six) in SCGU Order of Merit events.

## **GolfRSA Conditions**

Players that have moved to the Southern Cape, must be an affiliated member of a golf club
and handicapped in the Southern Cape region for at least 6 (six) months, before being
eligible for SCGU Team selection. The 6 (six) month window applies from handicap
effective date, until start of respective IPT/Team event. Exception may be granted by
GolfRSA should a player have permanently relocated to a different Union.

## Women's Mid-Amateur IPT

- The Women's Mid-Amateur Inter Provincial Tournament annually takes place in May, and the 4 (four) ladies will be announced in February/March of each year.
- Dynamic Order of Merit System will be used for the women's division. It remains the
  responsibility of the player to inform the Union of any national events that you played and
  your results in order to count for the SCGU Dynamic Ranking. Selected GolfRSA events will
  count for team selection.

## Age Limit

• Players must be 30 (thirty) years of age at the start of the Mid-Amateur IPT.

### **Minimum Requirements**

• A player must play in 4 tournaments (four) in SCGU Order of Merit events.

#### **GolfRSA Conditions**

Players that have moved to the Southern Cape, must be an affiliated member of a golf club
and handicapped in the Southern Cape region for at least 6 (six) months, before being
eligible for SCGU Team selection. The 6 (six) month window applies from handicap
effective date, until start of respective IPT/Team event. Exception may be granted by
GolfRSA should a player have permanently relocated to a different Union.

# **Women's 72 Hole Team Championships**

### Information

- The Women's 72 Hole Team Championship annually takes place in October, and the 3 (three) ladies will be announced in February/March of each year.
- Dynamic Order of Merit System will be used for the women's division. It remains the
  responsibility of the player to inform the Union of any national events that you played and
  your results in order to count for the SCGU Dynamic Ranking. Selected GolfRSA events will
  count for team selection.

#### Age Limit

- No age limit applies.
- The SCGU however retains the right not to select a golfer who is still of school going age to represent the Union at this level.

### **Minimum Requirements**

• A player must play in 6 tournaments (six) in SCGU Order of Merit events.

## **GolfRSA Conditions**

Players that have moved to the Southern Cape, must be an affiliated member of a golf club
and handicapped in the Southern Cape region for at least 6 (six) months, before being
eligible for SCGU Team selection. The 6 (six) month window applies from handicap
effective date, until start of respective IPT/Team event. Exception may be granted by
GolfRSA should a player have permanently relocated to a different Union.

### **SCGU Conditions**

 PLAYERS AT ANY LEVEL OF SELECTION MAY AT THE DISCRETION OF THE SOUTHERN CAPE EXECUTIVE COMMITTEE, BE OVERLOOKED FOR SELECTION, IRRESPECTIVE OF THEIR POSITION ON THE ORDER OF MERIT SHOULD SUCH PLAYERS HAVE A POOR TEAM PERFORMANCE RECORD & CONTRIBUTION TO TEAM MORALE, OR DISCIPLINARY RECORD AT EITHER TEAM, CLUB OR PROVINCIAL LEVEL.

## **Automatic Selection (Squad)**

- The top player on the GolfRSA Amateur Golf Ranking (Top 30).
- The top player on the SCGU Dynamic Ranking Order of Merit.

## Wild Card or Selectors Picks (Squad)

• The selectors may, at their discretion, select any one player who are members of a Golf Club affiliated to the SCGU. The selection of such players is not restricted to any minimum requirements or position on the Order of Merit.

#### **Team Selectors**

- SCGU Women's Golf President
- SCGU General Manager
- Additional Member

#### (CRITERIA EFFECTIVE 5 January 2022)

Southern Cape Golf Union retains the right not to select a representative side at any of the above levels if their sole opinion believe that a team selected in accordance with the above criteria would not be competitive.
